



## UNDERAGE PLAYER POLICY

**Form A – Minor Hockey**  
**Form B – Major Midget**

An Evaluation Committee comprised of a member of Minor Council and two other members of Development Council, will oversee the Underage Player Policy and manage each request.

The Underage Application process has two categories: (A) Minor Hockey and (B) Major Midget.

### CONDITIONS OF UNDERAGE STATUS

1. Registered teams of Hockey PEI shall adhere to the following criteria with respect to the use of under age players in any division of minor hockey.
2. Underage players requesting to be carded permanently for the season to AAA male, Major Midget or AAA female team **must** adhere to this policy. All other player movement is at the discretion of the local Minor Hockey Association. Minor Council reserves the right to review any player movement at their discretion.
3. The upward player movement shall be available for second year players (second year of eligibility of their proper age division) beginning in Novice. Players in their second year of a division are eligible to be evaluated for player movement to the highest category team in the next division of their minor hockey association club.
4. Players in Bantam male hockey requesting special status may only be permitted to move up to the Major Midget level and not for Midget AAA.
5. When players are requesting movement from Bantam to Major Midget, the association of the lower category team must be consulted regarding the use of the underage player.
6. IP players are not permitted to register with or affiliate with a Novice 'AA' team. At the discretion of the MHA, IP players may be moved to Novice "A".
7. No player of underage status may participate in any league games (exception – training camp, exhibition games) until approved by Hockey PEI.
8. Underage status will be granted for one year only.
9. Hockey PEI may revoke underage status at any time, when it has been deemed that the movement of the underage player is not in the best interest of the player. If status is revoked, such player will return to their appropriate age division for the remainder of the current season.
10. Exceptions to the policy will be reviewed in consultation with and approved by Minor Council Chairperson.
11. Each application will be reviewed independently and carefully.

### PLAYER RANKING

1. Players requesting movement to a higher category, the following will be taken into account to grant this status:
  - Overall hockey ability
  - Physical development
  - Social development
2. The use of the player must remain consistent with this ranking during the playing season or their status may be reviewed by a member of the Evaluation Committee.

<p>Players <b>must</b> at minimum rank in the top third (1/3) of their position (skill level) and have a significant impact in the applicable league of which the upper level team participates in.</p>	<p>Players <b>must</b> at minimum rank in the top half (50%) of their position (skill level) and have a significant impact in the applicable league of which the upper level team participates in.</p>

## EVALUATION PROCESS

1. A pre-requisite to obtain status to participate as an underage player with Hockey PEI, each player must be evaluated (on-ice) by an independent evaluator of Hockey PEI.
2. Evaluations will provide a recommendation to the Evaluation Committee on the ability of each applicant. This recommendation will be used by the Evaluation Committee in their decision to grant underage status or deny status to each applicant.
3. The evaluator(s) will be independent of the coaching staff of the team and will be appointed by the Evaluation Committee.
4. The evaluator will be a member of the development council or a designated representative.
5. Each applicant will be evaluated objectively by the evaluator.
6. Evaluations will be conducted during a game with the higher category division. The higher category team may arrange a date for the evaluation with Hockey PEI's technical director.
7. Minor Council may request if so desired that the evaluator and/or evaluation committee conduct a face-to-face interview with the applicant.
